



Gallery – Artist Agreement

Agreement entered into this date (_____), between The Absecon Cultural Arts Alliance, a 501-C-3 organization, (hereinafter referred to as the “ACAA”) and the artist _____ hereinafter referred to as the “Artist”.

- Whereas, the Artist is an artist of good standing; and
 - Whereas, the Artist wishes to have his/her artwork displayed by the ACAA; and
 - Whereas, the ACAA wishes to display the Artist’s work under the terms and conditions of this Agreement;
 - Now, therefore, in consideration of the foregoing exhibit and the mutual covenants hereinafter set forth, the parties hereto agree as follows:
1. Artist agrees to allow the ACAA to display the Artist’s artworks left with the ACAA for exhibition and sale. The works will only be displayed at the Galloway Library or ACAA affiliated business and for the duration as indicated by the ACAA.
 2. The ACAA may promote the Artist via their social media, web page and/or additional marketing materials. Additional advertising will be the sole responsibility of the Artist.
 3. It is up to the Artist to pay any and all necessary tax liabilities that may result in a sale of any artwork. All sales are between the Artist and Patron. All artwork submitted must be priced to sell or listed as NFS (Not For Sale).
 4. The ACAA uses a standard cleat hanging system. All artwork must be wire hung and gallery ready. Any artwork submitted that is not gallery ready will be refused. Artwork fashioned with sawtooth mount hardware or wire loop will neither be accepted nor hung. ACAA has the right to refuse exhibit of any artwork.
 5. Due to space constraints we ask that artists refrain from bringing in artwork larger than 20x30 inches and no heavier than 20 lbs.
 6. Any photographs, negatives, and any other property created in the course of the exhibition will be the property of ACAA. Artist consents to the ACAA using any image of their artwork in any of their promotional material including but not limited to website, Facebook, printed media ads, etc.
 7. ACAA will not be responsible for any of the artwork displayed by the Artist. The Artist is displaying his/her artwork at his/her own risk. It is the sole responsibility of the artist to maintain items held as stock, this may include tarnish removal, repairs and pricing. The ACAA reserves the right to remove items from display if damaged, tarnished or shop worn. ACAA will not reimburse the Artist for any damaged/lost/stolen artwork.
 8. Artwork must remain on exhibit for the duration of the exhibit. Artist is required to remove his/her artwork upon notice from the exhibit at the close of the current show. If the Artist does not remove his/her artwork on date of pick up or make arrangements for artwork to be picked up the ACAA may try to rehang artwork if deemed theme appropriate, however the artwork will not be eligible for judging during the second round and may be removed at ACAA discretion and stored off site if necessary. Artwork held on site will be hung in the meeting room if space is available. Please notify the ACAA if artwork will be picked up after the pick up date.
 9. The ACAA reserves the right to refuse any artwork not deemed appropriate at their discretion. We are a community based organization and adhere to an all ages appropriate policy. Items on display are in a public forum, therefore, we request no nudity, violence, or controversial subject matter.
 10. Modifications: All modifications of this Agreement must be in writing and signed by both parties. This Agreement constitutes the entire understanding between the parties hereto.
 11. Artist shall indemnify, save and hold harmless the ACAA, its officers, directors, employees, volunteers and agents and the participating exhibition venues from any and all claims, demands, causes of action and judgments, losses, costs and expenses, including but not limited to reasonable attorney's fees, arising due to the negligence of Artist, Artist's employees, agents or other person for whom they may be responsible, including but not limited to any representation, warranty, term or condition contained in this Agreement.

The parties hereto have executed this Agreement on the day and year above set forth.
